

Sunrise Golden's Farms Health Guarantee

Seller: Seller guarantees that the puppy has had proper care to date and has been checked by a veterinarian. Puppy has received its first shots and wormed. Records will be provided when puppy is picked-up.

- Seller is not responsible if puppy contacts a communicable disease after leaving breeder's possession. This includes worms, fleas, mites, cocci, giardia, or any other parasite common in dogs and puppies. **Relocation, travel, and separation from their littermates can stress a puppy causing the puppy not to eat properly for a few days. This should clear up in a few days. If it does not, have a veterinarian examine it.*
- Temperament of the puppy, color, size, or look of any puppy is not guaranteed.

SELLERS LIMITED WARRANTY:

Hips & Elbows: Hips/Elbows dysplasia is an illness that is not just genetic, but also dependent on the way the puppy is raised. Feeding a top diet and moderate exercise are key to ensure healthy joints and bones.

Sunrise Golden's offers a warranty on this puppy until the age of 12 months from the date of birth from developing "Moderate" or "Severe" hip dysplasia. Ratings that are "unilateral" on hip or elbow are not covered under this warranty. If a condition, as mentioned, does arise, the steps below must be followed:

- **Please notify Sunrise Golden's by mail or personally**
- Supply Seller with all documentation (including x-ray copies, copies of OFA reports, copies of all vet checks, vaccinations, etc.)

NOTE: x-rays must be submitted to the Orthopedic Foundation for Animals, University of Missouri, Columbia, MO 65210. We will accept a preliminary OFA test results, but not before the age of 18 months.

HEART/EYES: Seller will offer a warranty on this puppy until the age of 12 months from the birth date on any puppy with clinical signs of *genetic* heart or eye conditions (injuries are not applicable). If a condition, does arise, the steps below must be followed:

- **Please notify Sunrise Golden's by mail or personally**
- Supply Seller with a letter from the veterinarian stating that in his/her opinion the condition is congenital along with copies of all vet checks, proof of vaccinations, etc.

WARRANTY: In the unfortunate case that one of the above conditions occurs, the Seller will at their sole discretion do one of the following:

- Upon receipt of notifications and all required documentation, Seller will at their discretion take the puppy back and replace it with a puppy of equal value and of the same sex from a litter of Seller's choice at the Seller's convenience. Puppy must be returned to the Seller (along with papers) at the Buyer's expense. Seller will not be held liable for any expenses incurred by Buyer, including but not limited to vet bills and transportation costs.
- Seller will refund the price that was paid for this puppy.
- All veterinarian fees and expenses shall be the responsibility of the Buyer(s). Under no circumstances shall Sunrise Golden Retrievers, its owners, operators, or employees be held responsible for any expenses for any puppy not in the possession of Sunrise Golden Retrievers.

****No other warranties or verbal promises will be given, no exceptions.****

FEEDING AND NUTRITION: Feed and premium quality puppy / dog food.

Seller also highly recommends that this puppy be enrolled in a beginner obedience class. A well trained puppy/dog is desirable to be around.

This entire agreement between the two parties is not transferable.

In case of dispute, Buyer gives up all rights to a jury or civil trial and agrees to binding arbitration, at Buyer's expense, and any legal action for whatever reason would take place in the state and county of the residence of the Seller.
